DTRA Mission

Defense Threat Reduction Agency (DTRA) provides cross-cutting solutions to enable the Department of Defense, the United States Government, and international partners to **DETER** strategic attack against the United States and its allies; **PREVENT**, reduce, and counter Weapons of Mass Destruction (WMD) and emerging threats; and **PREVAIL** against WMD-armed adversaries in crisis and conflict.

Background

The Mentor-Protégé Program was created as a pilot program (Public Law 101-510) in 1990. The program was created by former Senator Sam Nunn and implemented by former Defense Secretary William Perry. Mentor-Protégé Program (MPP) was established as a pilot program and has periodically been reauthorized by Congress. The MPP was made permanent under the Fiscal Year 2023 National Defense Authorization Act (NDAA).

DTRA's Mentor Protégé Program (MPP) assists eligible Small Businesses (protégés) in developing their qualifications and ability to compete for prime contract and subcontract awards by partnering with large businesses (mentors). who provide developmental assistance under individual, project-based agreements to help meet the DTRA mission. Mentor-Protégé Program (MPP) Growing the Industrial Base

Types of Mentor-Protégé Agreements

Reimbursable: Reimburses mentors for allowable mentoring expenses, up to \$1M/year for up to 2 years.

Credit: Provides small business subcontracting credit to the mentor for the socioeconomic categories of the protégé using a multiplier (4X for direct labor costs; 3X for subcontracts, and 2X for other direct costs [ODCs]); Defense Contract Management Agency (DCMA) administers credit agree-ments.

Hybrid: Provides small business subcontracting credit for 1 year and reimbursement for 1 year. DCMA administers the credit portion and we jointly manage the reimbursable portion with DCMA.

- Human Resources training and certifications
- Marketing training, website design, branding
- Additive manufacturing improvements
- ISO certifications
- CMMI training and certification
- Implementing a Defense Contracting Auditing Agency (DCAA) accounting system
- Providing student interns for technology transfer/ development
